THE CHALLENGE OF HOMES4LIFE




The main challenge was to assess correctly in a certification scheme the aspects of social relations and personal relations in housing

- Inventory of scientific publications, good practices, methods, existing certifications
- List of all the existing KPIs
- Translation of these KPIs into requirements or surveys' questions
- More weight in the social, personal, and economic aspects than in physical characteristics and location of the building
- Addition of residents' surveys






WHAT MAKES OUR SITE SPECIAL?



This project is a demonstrator project and is based on design principals which can be replicated at a variety of scales.

The project will inform wider policy decisions relating to older person care and their short- and long-term viability.



WHAT MAKES OUR SITE SPECIAL?



- 1. Adaptable typologies.
- 2. Flexible Block Arrangements.
- 3. Clear grading of open spaces.
- 4. Resident first design.
- 5. Not allowing vulnerability to meet vulnerability.
- 6. Establishment of a Pattern Book as guidance.
- 7. Extensive public consultation.

WHAT HAVE YOU LEARNED AFTER TESTING THE HOMES4LIFE CERTIFICATE?




- Collaboration of multiple agencies is possible and desirable.
- 2. A high-level steering group is beneficial including detached, informed third parties.
- 3. The project has validated a collegiate way of working with policy makers.
- 4. The Co-Design process is highly valuable and will inform following projects.




WHAT HAVE YOU LEARNED AFTER TESTING THE HOMES4LIFE CERTIFICATE?



- 5. The regeneration and repurposing of historic buildings in established communities for this type of housing might be considered.
- 6. Appreciation of the life experience of older persons informs the design.
- 7. Some design principals can be integrated into all housing projects by default without material cost.



WHAT WE GAINED FROM HOMES4LIFE



Tests were conducted in the housing complex for autonomous elderly people (Résidence Autonomie) for 44 people and on the Nursing Home (EHPAD) for 125 people.



WHAT MAKES OUR SITE SPECIAL?



- Refurbishment of historical (public) buildings otherwise in disuse
- Co-created Model
- Central position of the site (no need for a car to reach main facilities)
- Accessibility and for all by design
- Availability of services (bus stops, healthcare, shops, groceries, etc.)
- Value proposition of housing model (social engagement, health support, ...)

WHAT HAVE YOU LEARNED AFTER TESTING THE HOMES4LIFE CERTIFICATE?



- Co-creation as a value for the model
- Underlined the importance of social and community spaces
- Confirmed that the model adopted for the first part of site [in use] has value and is worth replicating in the second part [in development]
- New insights on the importance of urban spaces and surroundings in the value of a residential building and impact on the possibility to age in place



WHAT MAKES OUR SITE SPECIAL?



- New way of occupying municipal town houses.
- Social mix ensuring equal proportions of tenents from different age and social groups as well as level of independence, that is: young people (leaving foster care), families with children, older people and people with disabilities.
- •Providing proper housing conditions for older and dependent people (to prevent social exclusion).
- Creating an open, tolerant community, in which unrelated people help each other.
- Common space "Neihbourgood Club" designed for all residents (a place which helps to build the potential of a local community).

WHAT HAVE YOU LEARNED AFTER TESTING THE HOMES4LIFE CERTIFICATE?



- The Homes4Life certificate made us aware of the importance of good integration between social, physical and economic aspects of senior citizens' housing.
- Detailed analysis of the site and its socio-spacial context helped us to understand better that the building's layout, its configuration and neighbourgood have an impact on the quality of life of residents.
- Survey with residents helped us to assess the level of their satisfaction with living in their new flats and in a community of the Multi-generational House. It's a good tool for evaluation in future projects.

The multi-generational house is part of a large-scale operation which aims at revitalising a former industrial district of Lodz hit by an eco-industrial crisis.

- •Transforming the environment, beyond the building, from a "home4life".
- •Reference need to be able to communicate with technical side (architects, engineers...).
- •Considering the evolving reality of users needs, and empowering process.
- Something to share:
 - A nice example is important.
 - Scaling tools necessary.
 - Change of approach compulsory.

The social-relational model replaces the medical model


